

Maldon Hospitality Action Giveaway – Terms and Conditions

Giveaway T&Cs

1. This giveaway is open to UK residents (England, Scotland, Wales and Northern Ireland only) aged 18 or over, excluding employees of Maldon Salt (which is the “Promoter”) and their immediate families, agents and anyone else professionally connected with this giveaway, including employees of Jellybean Creative (which is the “Organiser”).
2. A donation to Hospitality Action on their website, using the ‘reason to donate’ dropdown and choosing ‘Maldon Salt’ – making sure to tick the ‘agreement to share your personal data with Jellybean (on behalf of Maldon Salt)’ tick box – is necessary in order to enter this giveaway - <https://www.hospitalityaction.org.uk/donate/>
3. By entering this Maldon Hospitality Action Giveaway, you are deemed to have read and accepted these terms and conditions. The Promoter reserves the right to disqualify any entries which do not comply with these terms and conditions.
4. The Maldon Hospitality Action Giveaway opens on 1st July 2021 at 9:00 AM and closes on 30th July 2021 at 11:59 PM (which is the “Giveaway Period”).
5. To enter the Maldon Hospitality Action Giveaway, you must do the following:
 - On the donate page of the Hospitality Action website (<https://www.hospitalityaction.org.uk/donate/>), fill in your details and choose ‘Maldon Salt’ as the ‘reason for donating’ on the dropdown bar
 - Tick the ‘agreement to share your personal data with Jellybean (on behalf of Maldon Salt)’ tick box
 - Donate one of the suggested amounts or enter ‘other’ amount
6. Only one entry per person (by donating on the Hospitality Action website once).
7. Entries made on behalf of another person, or joint entries, will not be accepted. Entries from agents, organised group entries, bulk entries or entries automatically generated by computer will not be accepted.
8. Once the Giveaway Period has closed, 100 giveaway winners will be chosen at random by the Promoter from all valid and eligible entries submitted during the Giveaway Period. One of these winners will then be chosen at random to also win a meal for 2 at Norma London.
9. The 100 giveaway winners will be sent a parcel from the Promoter to the address given at the time of donating on the Hospitality Action website. The 1 winner of the meal for 2 at Norma London will also be contacted by email to claim their prize.

10. In the event that the address given is wrong or has details missing, the Promoter reserves the right to disqualify that winner and to award the prize to another participant.

11. Winners are responsible for ensuring that complete and correct details are provided on the Hospitality Action website in order to receive their prize.

12. By entering the Maldon Hospitality Action Giveaway, you confirm that you are eligible to do so and eligible to receive the prize. The Promoter may require you to provide proof that you are eligible to enter the giveaway in order to verify this.

13. In the event that circumstances beyond the reasonable control of the Promoter affect, or could affect, the proper operation of this giveaway, the Promoter reserves the right to cancel or amend the giveaway or these terms and conditions at any time but will make every effort to avoid causing undue disappointment to participants where such action is deemed necessary.

contestants, fans of Promoter or directly aimed at the Promoter, you will have your comments removed and your entry disqualified. We reserve the right to alert the relevant social provider to any such behaviour and you may have your account frozen pending investigation.

25. Nothing in these terms and conditions shall confer any rights on any person under the Contracts (Rights of Third Parties) Act 1999.

26. These terms and conditions shall be governed by and construed in accordance with the laws of England. Any dispute arising under these terms and conditions (whether such disputes or issues are contractual or non-contractual in nature, such as claims in tort, for breach of statute or regulation or otherwise) shall be subject to the exclusive jurisdiction of the courts of England.
